PROCEEDINGS OF THE ALLENDALE TOWNSHIP ELECTION COMMISSION SEPTEMBER 25, 2023

The Allendale Township Election Commission met at the Allendale Township Hall, located at 6676 Lake Michigan Drive, on Monday, April 17, 2023, at 5:00 p.m. and was called to order at 5:04 p.m. by Ms. Hansen.

EC 23-008 Ms. Schuitema moved to approve the agenda of today as presented. The motion passed.

Ms. Hansen gave a recap of Proposal 2022-2 regarding early voting, including the costs of different options to implement the process.

She explained the status of the Early Voting Agreement with the county and the proposed amendments the Ottawa County Commissioners have requested for the existing agreement. She outlined an option for Plan B, which is a multijurisdictional Early Voting Agreement. Plan B was created if the amended Early Voting Agreement with the county does not pass at the county commission meeting tomorrow, September 26, 2023. She outlined the state deadlines for informing the county clerk's office of how Allendale Township would be conducting early voting.

PRECINCT CONSOLIDATION

At a meeting of the Election Commission of the Charter Township of Allendale, Ottawa County, Michigan, held at the Township Hall located at 6676 Lake Michigan Drive, Allendale, Ottawa County, Michigan on January 29, 2024, at 9:30 am.

The Township Clerk advised the Election Commission that the next order of business was the consideration of a resolution to authorize Blendon Township to host the May 7, 2024, election on behalf of Allendale Charter Township and to temporarily combine Allendale Charter Township Precinct 5 with Blendon Township Precinct 3 for the May 7, 2024 school election.

After discussion, the following resolution was offered by x and supported by x:

RESOLUTION

WHEREAS, Public Act 116 of 1954, MCL 168.54 to 168.661, provides for Township Election Commissions to divide, rearrange, or temporarily consolidate election precincts; and

WHEREAS, Hudsonville Public Schools District has a ballot initiative on the May 7, 2024, election which is not a federal, statewide, or other general election, and is a school election;

WHEREAS, Allendale Charter Township has a minimal number of voters that will be affected by the election on May 7, 2024;

WHEREAS, Blendon Township has agreed to host the election for Allendale Charter Township Precinct 5;

WHEREAS, it is in the best financial interest to consolidate Precinct 5 with Blendon Township Precinct 3 and assign a temporary polling location of Bauer Reformed Church, 4958 Bauer Road, Hudsonville, MI 49426 for this election.

NOW, THEREFORE BE IT RESOLVED, BY THE ELECTION COMMISSION OF THE CHARTER TOWNSHIP OF ALLENDALE, OTTAWA COUNTY, MICHIGAN AS FOLLOWS:

- 1. The Election Commission of Allendale Charter Township approves the temporary consolidation of the above noted precinct within the jurisdiction of Blendon Township;
- The Township Clerk and her designees are authorized and directed to undertake or arrange these changes to the full extent necessary including proper voter notification; and
- 3. All resolutions in conflict herewith in whole or in part are hereby revoked to the extent of such conflict.
