

**ALLENDALE CHARTER TOWNSHIP
ORDINANCE NO. 2017 - 2
ZONING MAP ORDINANCE AMENDMENT**

APPLICANT: ALLENDALE CHARTER TOWNSHIP BOARD

An Ordinance to amend certain portions of the Zoning Ordinance and Map of Allendale Charter Township, Ottawa County, Michigan for the purpose of rezoning certain lands from PID, Planned Industrial District and I-1, Light Industrial District to the I, Industrial Zoning District.

THE CHARTER TOWNSHIP OF ALLENDALE, COUNTY OF OTTAWA, AND STATE OF MICHIGAN ORDAINS:

SECTION 1. Rezoning from PID, Planned Industrial District and I-1, Light Industrial District to the I, Industrial Zoning District.

The Zoning Ordinance and Map of the Charter Township of Allendale, Ottawa County Michigan, which map is incorporated by reference in the Zoning Ordinance for the Charter Township of Allendale, pursuant to Section 4.02, shall be amended so that hereafter the lands described within this Zoning Map Amendment shall be zoned and included in the I, Industrial Zoning District on said Zoning Map.

The properties being rezoned to the I, Industrial District are those properties zoned PID, Planned Industrial District and I-1, Light Industrial District as illustrated on the Allendale Charter Township Zoning map dated July 2016.

SECTION 2. Effective Date. That the foregoing amendments to the Allendale Charter Township Zoning Ordinance were approved and adopted by the Township Board of Allendale Charter Township, Ottawa County, Michigan, on _____, after a public hearing as required pursuant to Michigan Act 110 of 2006, as amended, and after introduction and a first reading on January 9, 2017, and publication after such first reading as required by Michigan Act 359 of 1947, as amended.

This Ordinance shall be effective on _____, which date is more than 7 days after publication of the Ordinance as is required by Section 401 of Act 110 of 2006, as amended, provided that the effective date shall be extended as necessary to comply with the requirements of Section 402 of Act 110 of 2006, as amended.
