Text Amendment Hearing: The hearing is to consider text amendments to the Allendale Charter Township Zoning Ordinance by amending Section 12.05C – Development Requirements for All PUD’s, Utilities and, by adding Section 3.18 – Marihuana Facilities and Establishments Prohibited.

Amendment One: The following is a summary of the text amendment to Section 12.05C of the Zoning Ordinance:

Section 12.05C – Development Requirements for All PUD’s, Utilities

The proposed amendment to Section 12.05C will require connection to public water and public sanitary sewer for all Planned Unit Developments pursuant to the Allendale Charter Township Subdivision Ordinance and will maintain the existing stormwater provisions.

Amendment Two: The following is a summary of the text amendment to add Section 3.18 to the Zoning Ordinance:

Section 3.18 – Marihuana Facilities and Establishments Prohibited

The proposed amendment to add Section 3.18 will prohibit any and all types of a marihuana establishment as defined in the Michigan Regulation and Taxation of Marihuana Act and, prohibit any and all types of marihuana facilities as defined in the Medical Marihuana Facilities Licensing Act. The amendment does not limit the privileges, rights, immunities, or defenses provided by the Michigan Medical Marihuana Act.
