WATER FACT SHEET As of January 1, 2022

Where utility service is wanted, application must first be made at the Allendale Township Office for plumbing permit(s) **and** water/sewer connection(s). At that time the property owner must pay certain fees and make arrangements to finance all unpaid fees in the Water Sewer Department.

The following fees must be paid at the time of application:

METER WITH RADIO READ (See Table Below)
INSPECTIONS (Payable to Planning & Development Department)
CROSS CONNECTION CONTROL DEVICE INSPECTION FEE = \$70.00
(This fee will apply to all non-residential meters)

The following fees can be financed for 5 or 10 years (depending on amount being financed) at an interest rate to be determined at time of connection. These fees (Special Assessments) will be billed April 1st of each year and be due April 30th.

CONNECTION CHARGE REU = \$ 2,639.00 per REU PUBLIC LATERAL = \$ 600.00

- 1. PRIVATE LATERALS: Installation is the responsibility of the owner, subject to Township inspection and approval and must be maintained by the owner.
- 2. MINIMUM COMMODITY WATER CHARGE: Quarterly there will be a minimum water charge equivalent to 3,000 gallons of usage. This covers administration costs.
- 3. QUARTERLY BILLING: Billing dates are:
 APRIL 15, JULY 15, OCTOBER 15, JANUARY 15
- 4. BANK RETURNED CHECKS are charged \$25.00 each.
- 5. METERS: Following is the initial cost and the quarterly charge for meters, per size. All single family residences use a 3/4" meter and duplexes use a 3/4" meter. All other sizes are determined by the Township Department of Public Works.

- 7. WATER SHUT OFF NOTICE: \$50.00
- 8. WATER TURN ON FEE: \$100.00 fee for turning on after shut-off for nonpayment
- 9. SERVICE CALL: \$75.00/\$100.00 (regular/emergency hourly rate), minimum 1 hour
